This art/craft fair is held in the 300 block of 5th Avenue in Downtown Clinton, Iowa, rain or shine. The Downtown Partnership, a non-profit group of volunteers, proceeds will be donated to the Downtown Events Committee, to help fund future activities in the downtown area. There is no admission charged to the public.

Deadline for Registration is September 1, 2009

Location: Three hundred block of 5th Avenue South, Clinton Iowa

Hours for booths: 10:00 AM to 4:00 PM

Cancellation Policy: All cancellations must be made in writing and postmarked on or before August 31, 2009. Any accepted artist/crafter, who cancels from the show prior to August 31, will be entitled to a refund less a \$10 processing fee, provided the space is filled by another artist/crafter. Absolutely no refunds will be made for cancellations postmarked after August 31.

Rules:

All Artist & Craftsmen over the age of 18 professional or amateur are invited to exhibit and sell their work.

All exhibitors must provide their own display, tables, chairs, and canopy. All storage must be contained and concealed within booth areas.

All booths will be on pavement with **NO** staking or drilling permitted. Structures should be built to withstand gusty winds. Sandbags and/or other appropriate equipment is required to ensure the stability of displays. Any artist/crafter with a hazardous display will be required to close and will forfeit their registration.

No gas powered generators allowed

Exhibitors are required to collect and submit IA state sales tax.

The Downtown Partnership has the authority to request the removal of any exhibit or undesirable items.

Booth must remain open during the festival hours.

Set-Up: Set-up time begins Saturday morning at 8:00 AM. (If an earlier time is needed please contact us to arrange.)

Tear-down: Tear-down is not permitted until close of festival! **NO** vehicles will be allowed on festival grounds until the Events Committee deems it is safe to do so! **NO EXCEPTIONS!** Failure to abide will result in future non-participation.
